Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), the Company has today entered into a Share Purchase Agreement ("SPA") with Sekura Roads Limited, to sell and transfer the entire equity shareholding held by the Company in Jorabat Shillong Expressway Limited ("JSEL"), a wholly owned subsidiary of the Company. The transaction is subject to receipt of approvals from National Company Law Tribunal and National Highways Authority of India.
